

# MEETING MINUTES COASTAL BEND COUNCIL OF GOVERNMENTS March 22, 2024 - 2:00 PM Corpus Christi, Texas

The meeting of the Board of Directors of the Coastal Bend Council of Governments was held at 2:00 pm on Friday, March 22, 2024. This meeting was held in hybrid format by videoconference pursuant to Texas Government Code Section 551.127 which states a governmental body that extends into three or more counties may meet by videoconference call only if the member of the governmental body presiding over the meeting is physically present at the location of the meeting. Judge David Krebs, San Patricio County, Chairman, was present at the meeting. Board members and individuals from the public who desired to attend in person, accessed the meeting at 2910 Leopard Street, Corpus Christi, Texas.

#### 1. CALL TO ORDER

Judge David Krebs, San Patricio County, called the meeting to order at 2:00 pm. Interim Executive Director Veronica Toomey called roll and confirmed a quorum.

#### 2. APPROVAL OF MINUTES OF FEBRUARY 23, 2024 MEETING

One correction was made to the February 23, 2024 meeting minutes in regards to Resolution No. 4079, a resolution authorizing the Coastal Bend Council of Governments to become a member of the American Flood Coalition. Resolution No. 4079 was approved by a majority vote present and Councilmember Gil Hernandez, City of Corpus Christi, was not present to vote. A motion was made by Judge Connie Scott, Nueces County, to approve the February 23, 2024 Meeting Minutes with the correction. The motion was seconded by Commissioner Lilly Wilkinson, San Patricio County. The February 23, 2024 meeting minutes were approved by unanimous vote.

#### 3. TREASURER'S REPORT

Veronica Toomey, Interim Executive Director, presented a report on cash transactions and month-end cash balances for the month of February 2024. Judge Charles Burns, Kenedy County, moved to approve the February 2024 Cash Report and Commissioner Dennis DeWitt, Bee County, seconded the motion. The Treasurer's Report was approved by unanimous vote.

#### A. HOMELAND SECURITY ADVISORY COMMITTEE

#### - RESOLUTION NO. 4084

A resolution authorizing the funding allocation for the FY2025 State Homeland Security Grant Funds in the Coastal Bend Region.

Mr. RJ Thomas, Homeland Security Director, presented Resolution No. 4084. Commissioner Dennis DeWitt, Bee County, made a motion to approve Resolution No. 4084 and Commissioner Chuck Schultz, Kleberg County, seconded the motion. Resolution No. 4084 was approved by majority vote.

#### B. ADVISORY COUNCIL ON AGING

#### (1) RESOLUTION NO. 4085

A resolution authorizing the Interim Executive Director to execute a contract agreement for FY2024 – FY2027 with the following contractor: Saenz Home Health Services, Inc.; to provide supportive services for Respite In-Home, Personal Assistance, and Residential Repairs as one of the contractors that will be part of the Area Agency on Aging's Contractors Purchase Pool for the provision of supportive services for targeted older persons in the eleven county Coastal Bend area beginning March 1,2024 through September 30, 2027.

Ms. Viola Monrreal, Director, Area Agency on Aging, presented Resolution No. 4085. Commissioner Chuck Schultz, Kleberg County, made a motion to approve Resolution No. 4085 and Councilmember Roland Barrera, City of Corpus Christi, seconded the motion. Resolution No. 4085 was approved by unanimous vote.

### (2) RESOLUTION NO. 4086

A resolution authorizing the Interim Executive Director to execute contract agreements and contract extensions extending from fiscal year October 1, 2023, to current contract agreements with local service provider Nueces County for the project period October 1, 2023, through September 30, 2027, supporting Older American's Act nutrition programs in the planning amount of \$3,159,509.

Ms. Viola Monrreal, Director, Area Agency on Aging, presented Resolution No. 4086. Judge Charles Burns, Kenedy County, made a motion to approve Resolution No. 4086, and Commissioner Leslie Casterline, Aransas County, seconded the motion. Resolution No. 4086 was approved by unanimous vote.
