# MEETING MINUTES COASTAL BEND COUNCIL OF GOVERNMENTS December 13, 2024 - 2:00 PM Corpus Christi, Texas

The meeting of the Board of Directors of the Coastal Bend Council of Governments was held at 2:00 pm on Friday, December 13, 2024. This meeting was held in hybrid format by videoconference pursuant to Texas Government Code Section 551.127 which states a governmental body that extends into three or more counties may meet by videoconference call only if the member of the governmental body presiding over the meeting is physically present at the location of the meeting. The Honorable David Krebs, Judge, San Patricio County, Chairman, was present at the meeting. Board members and individuals from the public who desired to attend in person, accessed the meeting at 2910 Leopard Street, Corpus Christi, Texas.

#### 1. CALL TO ORDER

Judge David Krebs, San Patricio County, called the meeting to order at 2:00 pm. Executive Director Emily Martinez confirmed a quorum.

#### 2. APPROVAL OF MEETING MINUTES

Mayor JoAnn Ehmann, City of Ingleside on the Bay, made a motion to approve the September 27, 2024 meeting minutes. Commissioner Leslie Casterline, Aransas County, seconded the motion. The September 27, 2024 meeting minutes were approved by unanimous vote.

#### 3. TREASURER'S REPORT

Treasurer, Mayor JoAnn Ehmann, City of Ingleside on the Bay, presented reports on cash transactions and month-end cash balances for the months of September, October, and November 2024. City Manager Cedric W. Davis, Sr., City of Mathis, made a motion to approve September, October, and November 2024 Cash Reports and City Commissioner Norma Nelda Alvarez, City of Kingsville, seconded the motion. The Treasurer's Report was approved by unanimous vote.

Chairman, seconded the motion. All ten consent agenda items were approved by unanimous vote.

- 1. Motion to approve the final notification of funds available for FY2024 for Community Action Corporation of South Texas (CACOST) for the period of 10/01/2023 09/30/2024 in the amount of \$966,769.
- 2. Motion to approve the final notification of funds available for FY2024 for the City of Corpus Christi for the period of 10/01/2023 09/30/2024 in the amount of \$1,300,286.
- 3. Resolution #4100 authorizing the Executive Director to accept fiscal year 2025 contracting plan summary for local nutrition service providers in the amount of \$2,512,226 based on estimates from the Health and Human Services Commission.
- 4. Resolution #4101 authorizing the Executive Director to execute contract amendment extending from Fiscal Year October 1, 2023 to September 30, 2024 to the current local service provider: Aransas County Council on Aging, Kleberg County, Live Oak County, Refugio County, Duval County and Community Action Corporation of South Texas for the project period October 1, 2024 to September 30, 2025 in the amount of \$2,512,226.

**Background**: VIP Provider Services is a current contractor who has requested an amendment to increase their hourly rate from \$13.05 to \$14.95 for Respite and Provider Services for the provision of respite services. effective February 1, 2025.

**Summary**: VIP Providers Inc. provides supportive services through Title III-B and Title III-E funding for the provision of Respite and Provider services for caregivers of persons aged 60 and over through the Area Agency on Aging of the Coastal Bend.

**Financial Impact**. There is a financial impact on family members and/or caregivers which in most cases go without assistance or would have to pay out of pocket. Provider and/or respite services can be quite costly from \$14.00 to \$25.00 per hour depending on the contractor and number of hours needed. The AAA of Coastal Bend sets aside funds and allocates a dollar amount per family that can be utilized and provides respite to family caregivers.

WHEREAS, the strategies relating to the provision of in-home and personal assistance supportive services (totaling approximately \$55,306 of Title III B Supportive Services funds \$ 51,600 in Title IIIE Family Caregiver's Support Program funds, \$ 10,00 in State General Revenue funds III-E Match, \$20,000 in American Rescue Plan Title III-E, \$40,000 in PY III-E funds and program income of \$707.00 for a total \$177,613) through a contractor's direct purchase pool are part of the approved Area Agency on Aging's Action Plan for Fiscal Years 2024 - 2027; and

WHEREAS VIP Providers Inc approached Area Agency on Aging of the Coastal Bend to request to amend the contract for the sole purpose of increasing Respite In-Home and Personal Assistance Services from \$13.05 per hour to \$14.95 per hour and keep the Day Activity and Health Services the same rate of \$35.00 per hour. The amended contract would be for membership in a contractor's purchase pool with contracts ending in FY 2027 for the purpose of purchasing in-home and other supportive services for targeted elderly persons in an eleven-county area; and
